

**SEX OFFENDER INFORMATION FACT SHEET**  
**RISK LEVEL 3 NOTIFICATION**  
**Minneapolis Police Department**

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **5800 Block Of 45<sup>th</sup> Avenue South, The Morris Park Neighborhood.**

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

The Minneapolis Police Department is available to help you by providing you with useful information on personal safety. They will also provide tips to instruct your children on personal safety.

**THE RELEASED OFFENDER: Frank Leo Sexton Dob 03/15/64**

**DESCRIPTION OF OFFENDER: White Male, 5'7", 156 Lbs, Slender Build, Blue Eyes, Medium Length Blond Hair, Fair Complexion, With A Mustache And Goatee.**

**DESCRIPTION OF OFFENSE: Mr. Sexton was convicted of Criminal Sexual Conduct with a 28 year old adult female in 1994. This offender confronted this victim as she left a store, followed her, and used physical force in order to gain compliance. This sexual contact was interrupted by citizens. Neither victim or offender were acquainted. Mr. Sexton has a previous history of chemical abuse. Mr. Sexton was revoked from supervision in 2008 and returns to his former address in the 5800 block of 45<sup>th</sup> Avenue South on 06/22/2010.**

**CONDITIONS OF RELEASE: SUPERVISED RELEASE**

Successfully complete sex offender programming.

May not enter sexually explicit establishments or possess these materials.

Must maintain full time employment. \* Currently employed full time.

Comply with alcohol/drug programming. Submit to polygraphs.

May not own/operate a motor vehicle without agent approval.

May not own/operate any networking device w/internet capability or access social networking.

May not enter establishments that serve alcohol as a primary business.
